Introduction

- 1. In accordance to the UNEP/MAP Programme of Work and Budget for 2018-2019 (Decision IG.23/14) adopted by the 20th Ordinary Meeting of the Contracting Parties to the Barcelona Convention (Tirana, Albania, 17-20 December 2017), and on the kind invitation of the Government of France, the Specially Protected Areas Regional Activity Centre (SPA/RAC) is convening the Fifth meeting of the National Correspondents of the Strategic Action Programme for the Conservation of Biological Diversity in the Mediterranean Region (SAP BIO). The meeting will be held on 13 and 14 February 2019, in Marseille, France, at the Hôtel Mercure Centre Vieux Port (1, rue Neuve Saint Martin, 13001 Marseille).
- 2. The main objectives of this meeting are to:
 - review the Draft evaluation document of the Strategic Action Programme for the Conservation of Biological Diversity in the Mediterranean region (SAP BIO)
 - to elaborate further inputs to be included in the Draft evaluation document for its revised presentation to the Thematic Focal Points meeting on Biodiversity, to be held on June 2019 at Portoroz, Slovenia
 - to inform the participants on the progress in the elaboration of the document "State of the Environment and Development in the Mediterranean 2019" (SoED 2019) and to collect their views and suggestions concerning the content of its chapters on Marine and Coastal Biodiversity

- 4. Rules of procedure

7. The rules of procedure for meetings and conferences of the Contracting Parties to the Convention for the Protection of the Environment and the Coastal Region of the Mediterranean and its Protocols (UNEP/IG.43/6, Annex XI) will apply *mutatis mutandis* to the present meeting.

Election of officers

8. Subject to Rule 20 of the rules of procedure, the meeting will elect, from among the representatives of the Contracting Parties, a President, two Vice-Presidents and a Rapporteur.

Adoption of the agenda

9. Subject to Rule 14 of the rules of procedure, the provisional agenda appearing in document UNEP/MED WG.459/1 and annotated in the present document will be reviewed and proposed for adoption by the meeting, including the timetable contained in the annex to the present document.

Organization of work

- 10. The meeting will take place along one day and a half: the afternoon of Wednesday 13 February 2019 and the whole day of Thursday 14 February 2019.
- 11. Sessions are scheduled, on day 1 (13 February 2019), from 2.30 p.m. to 5.30 p.m. and on day 2 (14 February 2019) from 9.30 a.m. to 12.30 p.m. and from 2.30 p.m. to 5.30 p.m.
- 12. It is expected that the meeting addresses all items of the agenda within the allotted sessions. It is envisaged to close the meeting at 5.30 p.m., on 14 February 2019, after adopting its Conclusions and Recommendations.
- 13. Working languages of the meeting will be English and French. Simultaneous interpretation will be available during the plenary sessions of the meeting.

18. The works of the meeting under this Agenda Item will be conducted in bilateral sessions during which the Secretariat will meet separately with each country delegation to assess what is done and what is on-going concerning the activities planned by SAPBIO. For what has not been done the bilateral session will identify, where possible, the reasons and if it is planned or if the unfulfilled actions are still relevant for inclusion in the new SAPBIO. To facilitate the works of the bilateral session, the Secretariat prepared for each country an evaluation sheet included in document UNEP/MED WG.459/Inf.3. The delegates are kindly invited to collect the information needed to check the elements included in the sheet prepared for their respective countries. They are encouraged to start filling in the sheet before the meeting.

Agenda item 6. Briefing on the progress in the elaboration of the document "State of the Environment and Development in the Mediterranean 2019" (SoED 2019)

The Secretariat will present the Draft methodology for the analysis of coherence between regional documents adopted under the SPA/BD Protocol and provisions of the ICZM Protocol, as reflected in document UNEP/MED WG.459/Inf.6, together with preliminary findings from applying the proposed methodology to SAP BIO. The participants will be invited to review the presented information and provide their comments and suggestions, thus providing guidance to PAP/ RAC for methodology finalisation and development of full-scale analysis of coherence between SPA/BD and ICZM policy frameworks.
