Introduction

1.At their Twenty-first Ordinary Meeting (Naples, Italy, 2-5 December 2019), the Contracting Parties to the Barcelona Convention for the Protection of the Marine Environment and the Coastal Region of the Mediterranean, and its Protocols, invited the Specially Protected Areas Regional Activity Centre (SPA/RAC), to convene in 2021 the Fifteenth Meeting of Focal Points for Specially Protected Areas and Biological Diversity (SPA/BD) for the biennium 2020-2021.

2.Following the kind invitation of the Maltese Government, the meeting was supposed to be held in Malta. However, due to the sanitary conditions caused by the COVID-19 pandemic and following the recommendation of the United Nations Environment Programme / Coordinating Unit for the Mediterranean Action Plan (UNEP/MAP) - Barcelona Convention Secretariat, all meetings scheduled till July 2021 will be organized by teleconference. Hence, the Fifteenth Meeting of SPA/DB Focal Points will be held by videoconference, on 23-25 June 2021.

3. The following annotations to the provisional agenda have been prepared by the Secretariat to assist the meeting in its deliberations.
